

Voluntary Service Agreement No. / 2023

made and entered into on 2023 in Orońsko by and between **Centrum Rzeźby Polskiej**, ul. Topolowa 1, 26-505 Orońsko, entered in the Register of Cultural Institutions under the number RIK 20/92, REGON (statistical ID) 000879699 and NIP (VAT No.) 7991439395, represented by: Maciej Aleksandrowicz, Director, hereinafter referred to as the "Centre"

and

Mrs/Mr residing in (postal code: ..-...), ul., PESEL, hereinafter referred to as the „Volunteer”.

The Parties agree as follows:

§ 1

1. The Centre represents that it is an organiser of the 4th edition of the *International Symposium of Contemporary Sculpture* (hereinafter referred to as the *Symposium*), which will be held in the Centre from 3 to 17 September 2023.
2. The Centre represents that it is an entity for which voluntary services can be provided.
3. The Volunteer represents that:
 - 1) she/he has qualifications and meets conditions necessary to provide services hereunder;
 - 2) has familiarised herself/himself with the Symposium Rules;
 - 3) she/he has completed OSH and fire protection training;
 - 4) she/he has been informed about risks for health and safety related to her/his duties and principles of protection against those risks;
 - 5) she/he has been informed about her/his rights and obligations.
4. The Volunteer is entitled to benefits related to an accident suffered during the provision of the services referred to in § 2 hereof based on separate regulations.

§ 2

1. During the Symposium referred to in § 1.1 above, the Centre orders the Volunteer and the Volunteer commits herself/himself to:
 - 1) support participants of the Symposium during their artistic works with due diligence;

- 2) prepare the presentation of their own creations in a digital form (jpg files or Microsoft Power Point presentation);
 - 3) take an active part in events accompanying the Symposium: discussions, presentations, lectures.
2. The Volunteer shall not perform any other duties than those specified in Section 1 above, including in particular any duties which are subject to relevant qualifications.

§ 3

1. The Volunteer shall perform all activities hereunder in person.
2. The Volunteer shall perform the activities hereunder within the premises of the Centre.
3. The Volunteer shall keep confidential any and all information and personal data obtained in connection with or under this Agreement.
4. The Volunteer shall perform the services hereunder without payment.
5. The Volunteer shall be liable for damages caused to the Centre or participants of the Symposium, unless the damage is caused by circumstances that the Centre is liable for.

§ 4

1. Under this Agreement the Centre shall enable the Volunteer to:
 - 1) stay within the Centre from 3 to 17 September 2023;
 - 2) take part in accompanying events: discussion panels, lectures;
 - 3) present the Volunteer's own work during accompanying events;
 - 4) provide services in safe and healthy conditions with the use of necessary protective equipment; as well as
 - 5) provide accident insurance to the Volunteer.
2. The value of the Volunteer's services shall not constitute a donation to the Centre within the meaning of the Civil Code and tax regulations.

§ 5

§ 6

This Agreement may be terminated by the Centre without notice in the event of the occurrence of any circumstances that prevent any further performance of this Agreement, including in particular:

- 1) the loss of the Volunteer's rights necessary to perform this Agreement;

- 2) the violation of this Agreement by the Volunteer;
- 3) any damage caused by the Volunteer to the Centre or participants of the Symposium.

§ 7

1. All matters not provided for herein shall be governed by the Civil Code and the Act on public benefit activity and volunteerism.
2. All disputes arising herefrom shall be resolved by a common court having jurisdiction over the Centre.

§ 8

All amendments hereto shall be made in writing.

§ 9

The following attachments shall constitute an integral part of this Agreement:

- 1) Personal Data Processing Consent;
- 2) Information clause for a representative of the Centre and the Volunteer;
- 3) Consent to use the image.

INFORMATION CLAUSE FOR A REPRESENTATIVE OF THE CENTRE AND THE VOLUNTEER

9. You have the right to withdraw your consent to the processing of your personal data at any time, but the withdrawal of consent does not affect the lawfulness of the processing that was carried out in accordance with the law, before its withdrawal.
